The 2732rd session of the Council of the European Union - **JUSTICE and HOME AFFAIRS** - will take place on 1 (10h00) and 2 June 2006, in the Conference Centre - FIL, 5 rue Carlo Hemmer, Luxembourg, under the Presidency of **Ms Karin GASTINGER**, Federal Minister of Justice and **Ms Liese PROKOP**, Federal Minister of the Interior of Austria.
